That, you accused issued five cheques bearing No.285815, dated 06/03/2024 for an amount Rs.50,000/- (Rupees Fifty thousand only), cheque No.285821, dated 30/04/2024 for an amount Rs.4,68,000/- (Rupees Four Lakh Sixty Eight Thousand only), cheque No.285822, dated 18/04/2024 for an amount Rs.4,00,000/- (Rupees Four Lakh only), cheque No.285823, dated 20/03/2024 for an amount Rs.1,22,000/- (Rupees One Lakh Twenty Two Thousand only) and cheque No.285824, dated 01/03/2024 for an amount Rs.2,68,000/- (Rupees Two Lakh Sixty Eight thousand only) each of Bank of India, Miraj for the repayment to the complainant for discharge, in whole or in part, of debt or other liability, all cheques were returned unpaid with remark **"Funds Insufficient"** on 13/06/2024. Complainant issued written demand notice dated 10/06/2024

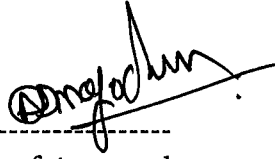
which is accepted by you accused on 12/06/2024. In spite of deemed service of demand notice you failed to repay the said cheque amount within 15 days to the above-mentioned complainant and thereby committed an offence punishable under Section 138 of the Negotiable Instruments Act, 1881.
