Plaintiff No.3 Gita Vijay Mali is present for herself and for plaintiff Nos.1 and 2 as a natural guardian. Defendant No.2 Sunil Shankar Gurav is present. They are identified by their respective advocates. Plaintiff No.3 and defendant No.2 have filed joint pursis at Exhibit 46. They intimated to this Court that, matter is amicably settled between them as per terms and conditions mentioned in the joint compromise pursis at Exhibit 46. It is further contended that, defendant No.2 has purchased the suit property described as 1/B from defendant No.1. As plaintiffs have share in it, defendant No.2 has issued Rs.4,60,000/- by way of cheque and in cash amount form, as mentioned in the pursis. Plaintiffs have relinquished their share in the suit property described as 1/B in the plaint in favour of defendant No.2. Therefore, plaintiffs do not want to proceed the matter against defendant No.2. There is no dispute against defendant No.2 and plaintiffs have no complaint against defendant No.2. Plaintiffs do not want to claim any relief against defendant No.2. However, plaintiffs are claiming relief against defendant No.1 in respect of the suit property described as 1/A in the plaint and plaintiffs wants to proceed the matter against defendant No.1. Thus, matter is amicably settled between plaintiffs and defendant No.2 as per terms and conditions mentioned in the joint compromise pursis at Exhibit 46. Therefore, in view of compromise pursis Exhibit 46, I pass the following order.
