**JUDGMENT**  
**( Date:-25.03.2026 )**

The particulars of the offence were read over and explained to the accused. He has pleaded guilty voluntarily. I have verified that, the accused has pleaded guilty voluntarily. Hence, I accept his plead.

Now, I heard the accused on the point of quantum of sentence. The accused has submitted that, he is only earning member of his family. This is his first offence and prayed for leniency. Learned A.P.P. submitted that maximum punishment may be awarded.

Considering the nature of offence, I am of the opinion that, this is fit case to take lenient view against the accused. Hence, I pass the following order.

**ORDER**

01. Accused **Rajendra Khandu Patil** is convicted vide Section 275 of Bharatiya Nagarik Surksha Sanhita, 2023 for the offence punishable under section 185 of Motor Vehicles Act and he is sentenced to pay fine of Rs.1,000/- (Rs. One Thousand), in default to suffer simple imprisonment for Five days.
