JUDGMENT

Accused is charged for the offence punishable under Section 281 of Bhartiya Nyaya Sanhita, 2023 by the Vita Police Station. Today accused is present. He voluntarily pleaded guilty to the charge leveled against him. He submitted that, this is his first offence and that his family is wholly dependent upon him. He prayed for showing leniency. Considering that the accused is the only earning member in his family and that his family is wholly dependent on him and that no previous offence is reported, a lenient view can be taken considering that he has pleaded guilty voluntarily and has shown repentance. Therefore, I accept his plea and I proceed to pass the following order.

ORDER

Accused Ashok Ajit Jadhav is hereby convicted vide Section 275 of the Bhartiya Nagarik Suraksha Sanhita, 2023 for the offence punishable under Section 281 of the Bhartiya Nyay Sanhita, 2023 and he is sentenced to pay fine of **Rs.500/-**-(Rs. Five Hundred only) in-default to suffer simple imprisonment for One days.
