Examination-in-chief by Special Assistant Public Prosecutor

Shri.A.A.Sagare -

1. My qualification is M.B.B.S., D.A. On 03/04/2022 I was attached to Rural Hospital Kadegaon as a Medical Officer. On same date I examined patients namely Vasant Ravindra Thombare & Ravindra Hariba Thombare. The patients came with Police Yadi. Both patients had stated history of assault on same day at 05.07 p.m. I found three injuries on Vasant.

- 1] Contusion over left chest, size of injury is 1 x 1 c.m.
- 2] Tenderness over left wrist, size of injury is 1 x 1 c.m.
- 3] Tenderness over abdomen, size of injury is 2 x 1 c.m.

2. Age all injuries within 6 hours. Those injuries are possible by hard and blunt object and simple in nature. I had given primary treatment to the patient.

3. After examination of the patient I issued medical certificate. Now it is shown to me is the same. It bears my signature. Its contents are true and correct. It is marked as Exh. 32

4. I found three injuries on Ravindra.

- 1] Abrasion over left forearm, size of injury is 0.5 x 0.5 c.m. with bleeding.
- 2] Tenderness over left side of chest, size of injury is 2 x 1 c.m.
- 3] Tenderness over left thigh, size of injury is 2 x 1 c.m.

5. Age all injuries within 6 hours. Those injuries are possible by

hard and blunt object and simple in nature. I had given primary treatment to the patient.

6. After examination of the patient I issued medical certificate. Now it is shown to me is the same. It bears my signature. Its contents are true and correct. It is marked as **Exh. 33**

4. Injuries are possible by fist blow and kick in scuffle. I bring MLC register and injury certificates. today.

Examination-in-chief is completed.

Cross-examination by Adv. Smt. D.D.Jagtap for accused -

5. Patients came to my hospital with police yadi. I bring carbon copy of that police yadi on today. It is not true to say that, I can not tell by which instrument patients were beat. Witness deposed that, patients were beaten by hard and blunt object. It is true to say that, I can not say by which hard and blunt object patients were beat. It is true to say that, injuries mentioned in Exh. 32 & 33 are possible if a person has contact with hard surface and if he falls from bicycle. It is true to say that, signatures of patients are not obtained on Exh.32 & 33. It is not true to say that, these injuries are not possible if person is beat by fist blow/hand. It is not true to say that, injuries of Vasanti are possible if she has habit of wearing tight under garments. It is not true to say that, I issued medical certificate as per say of patients.
