I was working as treasurer in A1 association till 2018. During my work tenure i used to maintain records and also sign the cheques which were presented before me for signature as treasurer. I had not worked in the day to day affairs of A1 association. I was traveling from one place to another place for business purpose and was not regularly working in A1 association. As per notification dated 16.10.2018 i had informed to A1 association that i will not be able to work regularly as a treasurer. Thereafter the members have passed the resolution and taken the powers of treasurer of A1 association and handed over to another person Joginder singh Lather. I do not know anything about the master resolution entered between complainant company and A1 association. I

had only signed the cheques which were presented before me pertaining to A1 association. Whenever i used to travel at that time the affairs of A1 association were looked into by accounts department. I do not know anything about the transactions taken place between complainant and A1 association. I have not received any demand notice of the complainant company. In the year 2015 resolution was passed wherein Joginder singh was made responsible for all the transactions and loans taken by financial institutions which also bears my signatures. In support of my defence i am producing the following documents,
