**ORDER BELOW (EXHIBIT No.01)  
(25/06/2026)**

1. Perused application, say and papers of investigation.  
Heard Learned Adv. Mr. D. E. Mane, for applicant/accused and  
learned APP Mr. P. S. Jannu, for State.
2. Present application is filed by the applicant/accused for  
grant of bail in regard to the offences punishable under Sections 7  
and 12 of Prevention of Corruption Act, registered vide C.R.  
No.378/2026 at Jail Road Police Station, Solapur.
3. It is the case of the prosecution that, on 19.06.2026

complainant lodged complaint against applicant and co-accused demanded bribe from the complainant. It is contended that bribe of Rs.1,000/- for the co-accused No.1, bribe amount of Rs.4,000/- for accused No.2 and bribe amount of Rs.1,000/- for himself is demanded, out of which Rs.1,000/- previously accepted under pretext to sanction withdrawal of Rs.5,00,000/- from the provident fund. The verification was conducted and trap was laid. During trap the applicant accepted the balance bribe amount from the complainant. On the basis of report lodged crime came to be registered against the applicant and co-accused.

4. Learned Adv. Shri. D. E. Mane for the applicant submitted that the applicant is falsely implicated in the crime. He has no concern with the alleged offence. He is ready to abide the conditions imposed and prayed for grant of bail.

5. Per contra, vide say Exh. 8 learned A.P.P. opposed the bail application. He submitted that there is role of the applicant in the crime. The applicant and co-accused demanded bribe from the complainant and applicant accepted it for himself and co-accused. He prayed for rejection of the application.

6. Considering the matter, the verification and trap panchanama are already prepared. The bribe amount is recovered. The offences are punishable upto 7 years. No criminal antecedents

are pointed against the applicant. The trial would take its own time. It would not be appropriate to keep applicant behind bar for indefinite period. Considering the matter, there would not be prejudice to the prosecution if suitable conditions are imposed to the applicant while granting bail to him. Hence, I proceed to pass following order.

**ORDER**

1. Criminal Bail Application No. 595/2026 is allowed.
2. Applicant- Vikram Harishchandra Barbole, be released on bail in C.R. No. 378/2026 registered at Jail Road Police Station, Solapur for offence under Sections 7 and 12 of the Prevention of Corruption Act, on furnishing PR bond of Rs. 50,000/- with surety in the like amount.
3. Applicant shall not tamper the prosecution witnesses and shall not try to abscond.
4. Applicant shall attend the Anti Corruption Bureau, Solapur on 1<sup>st</sup> and 3<sup>rd</sup> Saturday of every month between 10.00 am to 12.00 noon until filing of charge-sheet.
5. Bail application stands disposed of.
