



Order below Exh. 21 in Sessions Case No. 132 of 2025
(State of Maharashtra Vs. Manisha Mahesh Mane-Musale)
(Passed on 09/12/2025)

Sum and substance of present application is that the Investigating Officer has submitted CDR, SDR, CAF and SAF reports of persons viz. 1) Dr. Shirish Valsangkar (mobile No. 9284842504, 8830719784 and 9356599985), 2) Dr. Ashwin Valsangkar (mobile No. 9823030112), 3) Dr. Shonali Valsangkar (mobile No. 8422913413), 4) Neha Fadake (mobile No. 9423790166) and 5) Dr. Uma Valsangkar (mobile No. 9823094874) for the period 16/04/2025 to 20/04/2025. By a letter dated 13/06/2025 DCP Soapur had called information of said persons for the period 01/12/2024 to 02/05/2025. Despite, Nodal Officer has submitted information for very short period i.e. 16/04/2025 to 20/04/2025. It is contended that Dr. Shirish Valsangkar had long duration frequent calls with one unknown number 9371330952. So also, he had calls with Prajkta Raut. It is contended that data will be automatically deleted from the server. Hence, it is requested to issue summons to concerned Nodal Officer to produce all details of CDR, SDR, CAF and SAF.

2) The prosecution has filed say at Exh. 26 and opposed the application by contending that all copies of the document

supplied to the applicant. It is also contended that already a letter had been issued to a competent authority regarding said information and after receiving the information from concerned authority, the prosecution will produce the same before the Court.

3) Undisputedly, by virtue of a letter dated 27/10/2025, Senior Police Inspector of Sadar Bazar Police Station requested to the Nodal Officer, Solapur City to provide CDR, SDR, IMEI, IPDR, CAF and SAF in respect of phone numbers of seven persons viz. 1) Dr. Shirish Valsangkar (mobile No. 9823900112, 9284842504, 8830719784 and 9356599985), 2) Dr. Ashwin Valsangkar (mobile No. 9823030112), 3) Dr. Shonali Valsangkar (mobile No. 8422913413), 4) Dr. Uma Valsangkar (mobile No. 9823094874), 5) Neha Fadake (mobile No. 9423790166), 6) Prajakta Raut (mobile No. 7038755833 and 7) Rohini Raut (mobile No. 9371330952) for period 01/12/2024 to 02/05/2025. It is also undisputed facts that said information is not produced by concerned Nodal Officer.

4) It cannot be disputed that the prosecution entitled to establish its case by leading all cogent evidence. In the same way, the defence is entitled to defend his or her case by leading all such evidence. It is also undisputed facts for defending the case, the accused can opt Section 94 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for issuing summons and calling documents. It can be done at initial stage also. It is not necessary that accused may exercise said remedy at the time of leading his or her evidence. For

the purpose of contrading the witness and for the propose of utilizing the information, such summons can be issued even before framing charge. The Investigating Officer has already issued such letter to the Nodal Officer to produce the information. However, it seems that the Nodal Officer did not furnish the same. In order to give fair opportunity to the accused to defend her case, it would just and proper to issue summons and call detail information in respect of mobile phone stated in the application.

5) In the result, following order.

1. Application is allowed.
2. Issue summons to the Nodal Officer, Solapur City to produce CDR, SDR, CAF and SAF reports of persons viz. 1) Dr. Shirish Valsangkar (mobile No. 9823900112, 9284842504, 8830719784 and 9356599985), 2) Dr. Ashwin Valsangkar (mobile No. 9823030112), 3) Dr. Shonali Valsangkar (mobile No. 8422913413), 4) Dr. Uma Valsangkar (mobile No. 9823094874), 5) Neha Fadake (mobile No. 9423790166), 6) Prajakta Raut (mobile No. 7038755833 and 7) Rohini Raut (mobile No. 9371330952) for the period 01/12/2024 to 02/05/2025 on next date.
