ORDER BELOW EXH-1

The Accused produced before me alongwith the chargesheet for the offence punishable u/sec 8(c) r/w 27 (b) of N.D.P.S. Act. The particulars were framed against accused instantly. Same were read over and explained to him in vernacular to which he pleaded guilty voluntarily. The consequences of the pleading guilty were also explained to him. However, he continued with his plea. On the point of sentence, he prayed for leniency on the ground of poorness and he being the sole bread winner of his family. Considering the facts and circumstances of the case and the plea of the accused, I proceed to pass following order.

ORDER

1. Accused stands convicted for the offence punishable u/sec. 8(c) r/w 27 (b) of N.D.P.S. Act vide section 252 of Criminal Procedure Code and sentenced to pay fine of Rs. 1,000/- in default he shall undergo S.I. for 7 (seven) days.
2. The copy of order be given to accused free of costs.
