

SESSION CASE NO. 218/2016.
ORDER BELOW EXH. 62.

01. This is an application filed by accused Dr. Vijay Savaskar for permission to renewal of the passport for a period of 10 years.

02. According to him, offence punishable under sec. 307, 504, 506 r.w. 34 of the IPC is registered against him. However present case is stayed as per the order passed by Hon'ble High Court. Passport bearing No. U9113763 is issued him up to 14.03.2031. But the passport authority directed him to submit the fresh application due to non disclosure of the present case. According to him, as matter stayed by Hon'ble High Court, he had not disclosed about present case. He is reputed medical practitioner. He has immovable properties in Solapur. Lastly he prayed to grant him permission to renew his passport for further period of 10 years.

03. Say on application itself is filed by the prosecution. It is contended that, if permission granted, accused will flee away and will not remain present for trial. He will tamper evidence of prosecution. Lastly he prayed to reject the case.

04. Heard arguments of duo sides.

05. Considered respective submissions. It is an admitted fact that, initially passport of the accused was renewed till 14.03.2031. However as applicant had disclosed fact of this case, passport authority told him to submit fresh application. Verified copy of passport filed on record vide list Ex. 65. On perusal of the same it appears that, passport of applicant had renewed till 14.03.2031.

06. It is an admitted fact that, accused is medical practitioner. He is permanent resident of Solapur. According to him, he has immovable properties at Solapur. Incident is of the year 2016. Yet trial has not commenced. Accused/applicant is merely seeking permission for renewal of passport. Obviously applicant has to comply with other terms and conditions of the passport authority. However it is absolutely within the ambit of passport authority, whether the authority will renew passport of applicant for next 10 years or not. This Court merely could permit applicant for renewal of passport. Therefore, looking to the nature of the case, trial has not begun and considering profession of accused and his prayer of mere permission for renewal of passport can be allowed. With this following order is passed.

ORDER

01. Application is allowed.

02. Applicant Dr. Vijay Savaskar is permitted to renew his passport No. U9113763.
03. This order is passed only pertaining to the renewal of the passport.
04. The applicant shall not leave India without prior permission of this Court.
05. Application is disposed of accordingly.
