### **JUDGEMENT**

1. Accused appeared before the court and voluntarily pleaded guilty for the offence under section 185 of the Motor Vehicles Act, 1988. In view of statement of the accused in respect of offence and considering the answers to the plea of the accused, it is established that the accused has voluntarily pleaded guilty. The plea of guilty of the accused is accepted.
2. By considering the age of the accused and in view of nature of offence, imposing punishment of fine would meet the ends of justice and to avoid further commission of offence. Hence, in the result, I proceed to pass the following order.

### **ORDER**

1. The accused **Rajhamed @ Rajahmad Shaikh** is hereby convicted vide Section 252 of the Code of Criminal Procedure, 1973 for the offence punishable U/s 185 and 130(1)/177 of the Motor Vehicles Act, 1988.
2. He is sentenced to pay fine of **Rs.10,000/-** (Rs. Ten thousand only) for punishable **U/s 185** of the Motor Vehicles Act, 1988 and in default of payment of fine, he shall suffer simple imprisonment of 7 days.
3. The vehicle involved in the present case be returned by concerned authority to eligible claimant on due procedure if detained.
4. Matter stands disposed of accordingly.
