

ORDER BELOW EXH. 6
IN SPECIAL (POCSO) CASE No. 20/2025

The State of Maharashtra

Versus

Siddhesh Bhimrao Ghuge.

1. This is an application filed by accused No. 2 Vikas @ Vicky Nandu Bandgar, under section 497 of the Bharatiya Nagrik Suraksha Sanhita, 2023, for return of mobile V 30, I.M.E.I. No. 8601*****5495 in Special (POCSO) Case No. 20/2025, registered vide Crime No. 976/2024, Sangola Police Station.
2. It is contended by Ld. APP vide say that, the trial is yet to be commenced. The applicant is accused. Offence is serious. Applicant/accused may change the nature of mobile and destroy the evidence, so the muddemal can not be returned back. So, prayed that, the application be rejected.
3. Heard advocate for applicant and learned A.P.P. at length.
4. Here, it is not in dispute that, the said mobile was seized from the accused. Applicant/accused has filed tax invoice of said mobile on record. On perusal of same, it reveals that, applicant/accused is registered owner of said mobile. Here keeping in view that, mobile is seized from accused and he being the owner of mobile is entitled to get back the possession of his mobile. However, certain conditions are to be imposed. With this, I pass following order.

ORDER

- 1) Application is allowed.
- 2) The mobile mobile V 30, I.M.E.I. No. 8601*****5495, seized in Special (POCSO) Case No. 20/2025, registered vide Crime No. 976/2024, Sangola Police Station be given to the applicant Vikas @ Vicky Nandu Bandgar, R/o. Thombarewadi, Achakdani, Tq. Sangola, on following conditions...
 - a) Applicant is directed to execute Indemnity Bond of Rs. 30,000/- (Rs. Thirty Thousand only).
 - b) Applicant is further directed that, he shall not sell, transfer or make any changes of the said mobile till final disposal of case.
 - c) P.I., Sangola police station is directed to take two photographs of the said mobile and prepare panchanama and take detail address of the applicant along with proof.
 - d) P.I. Sangola police station is directed to submit Suprutnama photographs, documents and panchanama along with the charge sheet.
 - e) Issue letter accordingly.
