Budhisagar & 1 Vs. The State.

ORDER BELOW EXH. 04
(Dated 25.03.2026)

1. By filing this application, the applicants are claiming interim - anticipatory bail in connection with Crime No. 123/2026 registered with Pandharpur City police station under Sections 118(1), 352, 3(5) of BNS.
2. Heard learned advocate for applicant/accused. It is submitted that the main application is pending and if meanwhile the accused is arrested, the very purpose of filing this application would be frustrated. It is submitted that the applicant is falsely implicated in the alleged offence. He has no concern with the said offence. It is submitted that prima facie there is no case against the applicant and the allegations are vague. The applicant is ready to abide by any conditions if imposed by the Court.
3. I have gone through the record. On perusal of FIR, it reveals that, names of these applicants are not mentioned in the FIR. Moreover there are not any allegations against them. No recovery or discovery remained at the instance of these applicants. Applicant No. 2 is 80 years old citizen. Thus, as prima facie there seems no involvement of these applicants in the crime and as there is no recovery or discovery, I am of the view that it would be justifiable to grant interim protection to these applicants by imposing certain conditions. Hence, I proceed to pass following order.

ORDER

- 1) The application Exh. 4 is hereby allowed.
- 2) In the event of arrest, Budhisagar Tukaram Jadhav and Tukaram Anna Jadhav, Both R/o. House No. 123/2/B, New Solapur road, behind Reliance Petrol Pump, Pandhapur be released on interim anticipatory bail in connection with Crime No. 123/2026 registered with Pandhapur City Police Station on executing of PR bond of Rs. 25,000/- each with surety in the like amount each till disposing main petition.
- 3) The applicants shall not tamper with the prosecution case.
- 4) The applicant shall attend the concern police station on each Thursday in between 10.00 a.m. to 1.00 p.m. till disposal of main application.
- 5) Inform to the concern police station.
- 6) Issue notice to prosecution for filing say on main application.
- 7) Application Exh. 4 is disposed off.
