

Order passed below Exh.44 in Sessions Case No.33/2019

This is an application filed by applicant / accused No.4 Chandrashekhar Jaynarayan Kondubhairi for seeking directions to the Regional Passport Office Pune, to renew the passport No.M7767552.

2 As per contention of applicant, he is Diploma in Civil Engineering and he is involved in the present sessions case. His pass port bearing No.M7767552 is expired on 27.03.2025. Due to pendency of the proceeding, the passport authority will not renew the passport of the applicant and the passport is a public document to prove the citizenship of the country and it is very essential for him. The applicant supported his application by filing affidavit. He relied on his previous passport xerox copy adhar card copy.

3 Learned APP filed his say vide Exh.46 and strongly objected the application alleging that the the offence is serious one and evidence brought on record during trial. If he will allow to renew passport, then he will abscond. If he permitted then he will flee away and case will be pending.

4 Heard both parties. Perused record. The applicant has submitted that he placed on record the copy of application form of renewal however, it is not found on record. Despite it, the passport is a public document and its Form is also public documents. It is necessary to fill all the columns of application for renewal passport. On perusal of record it appears the crime is of year 2013 and the Sessions Case is pending since 2019. The applicant is civil engineer by profession and residing at Mangalwedha. The applicant / accused produced previous passport xerox copy, his adhar card. On perusal of record it appears, that the applicant / accused is charged with various sections of Indian Penal Code. The hearing of the trial is going on. It appears from the record that, due to pending of this case, the Passport Authority is not issuing or renewing the Passport to the applicant. It is to be noted here that this Court has no objection for getting passport to the accused but if wants to go outside the country, permission of this Court is

required. In view of the same, following order is passed.

ORDER

Application vide Exh.44 is allowed as below.

- 1** The applicant / accused Chandrashekhar Jaynarayan Kondubhairi is at liberty to get renewal of passport from Passport Authority, Pune.
- 2** This Court has not objection for issuing the renewed pass port to the present applicant / accused.
- 3** Application is disposed off accordingly.
