ORDER BELOW EXH. 1 IN MACP NO. 14/2019

(Mangal Dhotre Vs. Dagadu Chavan)

Applicant Nos. 1 to 4 are present with their advocate. The applicant Nos. 3 and 4 are minor and applicant No. 2 is their guardian. Authorised person appearing for Insurance opponent No. 2 is present. Respondent No. 1 is absent. Applicants and respondent No. 2 preferred compromise pursis Exh. 34 stating that, compromise is held between them and applicant does not want to proceed against opponent No. 1. The claim is settled to the tune of Rs. 22,00,000/- payable within one month. Hence Order :

ORDER

01. The application is disposed off in terms of compromise pursis Exh. 34.
02. Opponent No. 2 Insurance company to deposit Rs. 22,00,000/- (Rs. Twenty Two lakhs only) in Court within period of one month from today, failing which it will carry interest at the rate of 7 % p.a..
03. Opponent No. 2 to deposit the amount of award by way of NEFT/RTGS in account of Tribunal and shall send copy of the same to the claimant.
04. Claim against opponent No. 1 is disposed of as withdrawn.
05. Out of said amount an amount of Rs. 1,00,000/- from the share of applicant No. 1 be deposited in any Bank of Badoda, Branch Pandhapur for period of 3 years, in her name and amount of Rs. 1,00,000/- be given her.
06. Out of said amount an amount of Rs. 2,00,000/-

from the share of applicant No. 2 be deposited in Bank of Badoda, Branch Pandhapur for period of 3 years in her name and amount of Rs. 8,00,000/- be given to her.

07. Out of said amount an amount of Rs. 5,00,000/- from the share of applicant No. 3 be deposited in Bank of Badoda, Branch Pandhapur in his name till attaining majority.
08. Out of said amount an amount of Rs. 5,00,000/- from the share of applicant No. 4 be deposited in Bank of Badoda, Branch Pandhapur in his name till attaining majority.
09. Court fee if any be refunded as per rule to the applicants.
10. Petition is disposed off.
