ORAL ORDER

This is an application for the grant of anticipatory bail under section 438 of the Cr.P.C., in connection with C.R. No. 451 of 2014, registered with Kurar Police Station, for the offences punishable under sections 419, 420, 465, 468, 471, 201, 188, 120-B read with section 34 of Indian Penal Code and sections 4 and 5 of the Maharashtra Prevention of Gambling Act and section 66-A of the Information Technology Act.

2 Perused the application, the say filed thereon and the documents relied upon in support thereof.

3 Heard the learned counsel for the applicant and the learned APP for the State.

4 It is submitted by the learned counsel for the applicant that the applicant is not named in the FIR. Anticipatory bail is granted to co-accused Basu Jalan. Per contra, it is submitted by the learned APP that 18 sim cards of the applicant were used in gambling. The applicant was absconding, since 2014.

5 As per the say filed by the police, 18 sim cards of the applicant were used in gambling, by the main accused persons. The custodial interrogation of the applicant is necessary, in respect of the large quantity of sim cards used in the gambling. Co-accused Basu Jalan was granted anticipatory bail, as his role was different, as he was found to have involved in respect of running online gambling.

6 In the light of the above observations, I proceed to pass the following order :

ORDER

1) Anticipatory Bail Application No. 1649 of 2021 is hereby rejected and disposed of accordingly.

2) The concerned Police Station be informed accordingly.
