CHARGE

I, M. N. Patil, Judicial Magistrate, F. C., (Court No. 4) Malshiras is hereby charge you,

1. Krishnrao Shubhas Chavan
Age 28 yrs., Occu. Agriculture,
2. Bhusaheb Machindra Magar
Age 27 yrs., Occu. Agriculture,

Both R/o. Nimgaon Magar, Tal- Malshiras, Dist-Solapur

as follows,

1. **Firstly** :- That you both accused, on 12.11.2018 at about 3.15 p.m., on Khandali-Shripur road at Khandali, Tal. Malshiras, Dist. Solapur, in furtherance of your common intention, voluntarily caused hurt to the informant by means of stone as a weapon of offence, is likely to cause death, and that you thereby committed an offence punishable Under Section 324 read with Section 34 of Indian Penal Code and within my cognizance
2. **Secondly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention voluntarily caused hurt to the informant with fist and kick blows and that you have thereby committed an offence punishable Under Section 323 read with Section 34 of the I.P.C. and within my cognizance.
3. **Thirdly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, intentionally insulted and abused the informant and thereby gave them provocation intending that such provocation will cause them to break the public peace and that you thereby committed an offence punishable Under Section 504 read with Section 34 of the I.P.C. and within my cognizance.
4. **Lastly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention committed criminal intimidation by threatening the

informant with injury on him person and thereby committed an offence punishable
Under Section 506 read with Section 34 of the I.P.C. and within my cognizance

And I hereby direct that you be tried by me on aforesaid charge.
