Complainant / S. Ganapathi is present by filing Hazira.

Sole accused / Sreedhar on interim bail is also present by filing Hazira and vide a petition prays for its extension as was granted by this Court.

The aforesaid petition is duly perused, considered and stands allowed, under observation that since no adverse conduct at present is revealing against the accused, with a direction to extend the operation of the interim bail granted to the above accused by this Court as on 12.06.2024 till the next scheduled date.

Today was inter alia scheduled for making payment by accused in favour of the complainant to the tune of Rs. 3,00,000/- vide previous Order dated 28.06.2024.

At this stage, from the money receipt filed from the complainant side, the same inter alia reveals payment of the aforesaid sum this day which is taken into the case record.

At this stage, vide a petition from the complainant side, direction is sought for to withdraw the deposited sum in favour of the complainant by the accused on 28.06.2024 in the instant case.

The aforesaid petition is duly perused in presence of the respective Learned Counsels representing both the parties herein and duly concerned in the light of the available materials on record from which it inter alia reveals that a sum of Rs. 3,50,000/- vide Challan No. 03 dated 28.06.2024 was filed from the accused side in respect of the deposit of the said sum with the Cash Section of this Court vide previous Order dated 28.06.2024 of this Court.

In the light of the foregoing observations, the aforesaid petition filed from the complainant side stands disposed of with a direction upon the Cashier, Cash Section of this Court to release the aforesaid deposited sum of Rs. 3,50,000/- in favour of the complainant of this case namely S. Ganapathi upon maintaining all Codal formalities and in accordance with all Official norms and formalities.

There shall be a further direction upon the accused to pay the balance due sum of Rs. 6,50,000/- of the subject 2nd and final installment in respect of the impugned cheque amount on the next scheduled date in favour of the complainant, failing which necessary consequences shall follow.

Let a copy of the instant order be notified to the Cashier, Cash Section of this Court for necessary action and compliance.

Fix **29.07.2024** for making further payment by the accused / Sreedhar in favour of the complainant / S. Ganapathi to the tune of Rs. 6,50,000/- as the balance sum of the 2nd and final installment towards the impugned cheque amount as per aforesaid directions and for passing further necessary orders.

Accused / Sreedhar to remain present positively on the aforesaid scheduled date without fail before this Court.

Complainant / S. Ganapathi also to remain present.
