CHARGE

I, M. N. Patil, Judicial Magistrate, F. C.,(Court No. 4) Malshiras is hereby charge you,

1. Keshav Shivaji Jadhav
Age 50 yrs., Occu. Agriculture,
2. Bhausahab Shivaji Jadhav
Age 45 yrs., Occu. Agriculture,
3. Jayshri Keshav Jadhav
Age 39 yrs., Occu. Agriculture,

All R/o Malloli, Tal- Malshiras Dist-Solapur

as follows,

1. **Firstly** :- That on 10.05.2017 at about 12.30 am in front of informant's house at Malloli, Tal. Malashiras, Dist. Solapur, you accused in furtherance of your common intention voluntarily caused grievous hurt to informant and thereby committed an offence punishable under Section 325 read with Section 34 of the Indian Penal Code and within my cognizance.
2. **Secondly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention voluntarily caused hurt to the informant and witness by means of Sickle used as a weapon of offence, is likely to cause death, and that you thereby committed an offence punishable Under Section 324 read with Section 34 of Indian Penal Code and within my cognizance.
3. **Thirdly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, voluntarily caused hurt to the informant and witnesses with fist and kick blows and that you have thereby committed an offence punishable Under Section 323 read with Section 34 of the I.P.C. and within my cognizance.
3. **Fourthly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, wrongfully restrained the informant and prosecution witnesses thereby committed an offence punishable Under Section 341 read with Section 34 of the I.P.C. and within my cognizance.
5. **Fifthly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, intentionally insulted and abused the informant thereby gave them provocation intending that such provocation will cause them to break the

public peace and that you thereby committed an offence punishable Under Section 504 read with Section 34 of the I.P.C. and within my cognizance.

6. **Lastly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention committed criminal intimidation by threatening the informant with injury on him person and thereby committed an offence punishable Under Section 506 read with Section 34 of the I.P.C. and within my cognizance

And I hereby direct that you be tried by me on aforesaid charge.
