

ORDER BELOW EXH. NO.1 IN R.C.C. NO.313/2026.
(C.R.No.137/2026)

The accused are charge-sheeted for the offences punishable under sections 109, 118(1), 115(2), 126(2), 189(2), 189(4), 191(2), 191(3), 190 of the Bhartiya Nyaya Sanhita, 2023. The offence punishable under section 109 of the Bhartiya Nyaya Sanhita is exclusively triable by the Hon'ble Sessions Court. The accused No. 1 is in jail. Accused No. 2 to 5 are on bail. The chargesheet is not filed against accused No. 6 to 10. The copies of police report and other documents as specified in section 230 and 231 of the Bharatiya Nagarik Suraksha Sanhita, 2023 have been supplied to the accused. Accused have filed pursis at Exh.No. 13 and stated that they will present before the Hon'ble Sessions Court, Malshiras on 27/08/2026. The accused have been asked in respect of Legal Aid at the State expenses. However, they submitted before this Court that they have engaged their advocate for their defence and to conduct the trial before the Hon'ble Sessions Court, Malshiras. Therefore, the case is required to be committed to the Hon'ble Sessions Court, Malshiras. Hence, I Pass the following order :-

ORDER

1. The case be committed to the Hon'ble Sessions Court, Malshiras.
2. Jail Authority is directed to produce the accused No. 1 before the Hon'ble Sessions Court, Malshiras on **27/08/2026** at 11.00 a.m.
3. Accused No. 2 to 5 are directed to remain present before the Hon'ble Session Court, Malshiras on **27/08/2026** at

11.00 a.m.

4. The record of the case, the documents and articles which are to be produced in evidence shall be sent to the Hon'ble Sessions Court, Malshiras.
5. The Police Station Officer, Police Station, Natepute, Tal. Malshiras, Dist. Solapur is directed to produce the Muddemal properties in the Hon'ble Sessions Court, Malshiras on or before 27/08/2026 positively.
6. The Public Prosecutor shall be notified about the commitment of case to the Hon'ble Sessions Court, Malshiras.
