

<u>MHSO110024462024</u> 	<u>ORDER PASSED BELOW EXH. 6</u> IN <u>S.C.C No. 845/2024</u> <u>State Vs. Yogesh Sudhakar Ganbote</u> <u>[Date:09/06/2026]</u>

1. This application is filed on the behalf of applicant/accused namely Yogesh Sudhakar Ganbote for grant of "No Objection Certificate" from this Court for getting passport from Regional Passport office.

2. It is the contention of the applicant/accused that he owns and possesses immovable property situated at Village Kalaj, Tal. Phaltan, Dist. Satara. In support of this contention, he has produced a copy of the licence issued by the Food Safety and Standards Authority of India. It is further contended by the applicant/accused that he intends to travel abroad for the marketing of dairy products. For this purpose, he is required to travel beyond the territorial limits of India to foreign countries. Therefore, he requires a passport from the Passport Authority.

3. Ld. I.O. filed his say at Exh. 08 and the Ld. A.P.P filed his say overleaf of this application stating therein that if the permission is granted, accused will not remain present before the Court. Hence, he has prayed for rejection of the application.

4. From perusal of the application, it emerges that, present case i.e S.C.C.No. 845/2024 is pending against the applicant/accused.

The applicant/accused has filed copy of the licence issued by the Food Safety and Standards Authority of India, which shows that he is engaged in busniess of dairy products. Charge sheet also reveals that applicant/accused owns and possesses immovable property situated at Village Kalaj, Tal. Phaltan, Dist. Satara. He is ready and willing to abide each and every condition which will be imposed upon him. Therefore, merely on the ground of pendency of criminal case, there is no point to reject the present application.

5. Considering the above said discussion, the application deserves to be allowed. Hence, I pass following order.

- ORDER -

- 1) The application is allowed.
- 2) *No Objection Certificate* is granted to applicant/accused namely **Yogesh Sudhakar Ganbote** for getting passport from the Competent Authority to the extent of S.C.C.No. 845/2024.
- 3) Applicant/accused shall undertake to furnish the copy of passport and other relevant documents regarding the proposed tour, if any, in future.
- 4) Copy of this order be forwarded to the Officer in-charge of Police Station, Velapur.
