Age 33 yrs., Occu. Agriculture,
R/o – Tandulwadi, Tal. - Malshiras, Dist. - Solapur
3. Vishnu Bapurao Kakade
Age 77 yrs., Occu. Agriculture,
R/o – Tandulwadi, Tal. - Malshiras, Dist. - Solapur
4. Gitanjali Maruti Jadhav
Age 36 yrs., Occu. Household,
R/o – B 37, Room No 11, Shri Gurukrupa Housing Society, Sanpada
Sector-10, Navi Mumbai

as follows,

1. **Firstly** :- That you accused, on 03.07.2024 at 8.30 p.m., at witness Maruti Mile residence at Tandulwadi, Tal. Malshiras, Dist. Solapur, in furtherance of your common intention, voluntarily caused hurt to the informant by means of plastic pipe used as a weapon of offence, is likely to cause death, and that you thereby committed an offence punishable Under Section 181(1) read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance
2. **Secondly**, that you accused, on aforesaid date, time and place, in furtherance of your common intention, committed house trespass having made preparation for causing hurt, assault to informant or put her in fear of hurt of assault and you have thereby committed offence punishable under Section 333 read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance
3. **Thirdly**, that you accused, on aforesaid date, time and place, in furtherance of your common intention, voluntarily caused hurt to the informant with fist and kick blows and that you have thereby committed offence punishable under Section 115(2)

read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance

4. **Fourthly**, that you accused, on aforesaid date, time and place, in furtherance of your common intention, commits the offence of criminal intimidation thereby committed offence punishable under Section 351(2) read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance

5. **Fifthly**, that you accused, on aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening the informant with injury on him person and thereby committed offence punishable under Section 351(3) read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance

6. **Lastly**, that you accused, on aforesaid date, time and place, in furtherance of your common intention, intentionally insulted and abused the informant and thereby gave them provocation intending that such provocation will cause them to break the public peace and that you thereby committed an offence punishable Under Section 352 read with Section 3(5) of The Bharatiya Nyaya Sanhita, 2023 and within my cognizance

And I hereby direct that you be tried by me on aforesaid charge.
