I, M. N. Patil, Judicial Magistrate, F. C., (Court No. 4) Malshiras do hereby charge you,

Age 23 yrs., Occu. Labour
R/o – Nimgaon, Tal- Malshiras, Dist- Solapur
4. Ganesh Namdev Torne
Age 21 yrs., Occu. Labour
R/o – Nimgaon, Tal- Malshiras, Dist- Solapur
5. Manisha Niteen Kengar
Age 31 yrs., Occu. Labour
R/o – Phule Sahau Ambedkar Nagar, Velapur Tal- Malshiras, Dist- Solapur

as follows,

1. **Firstly** :- That you accused, on 08.07.2023 between 8.30 a.m. to 09.00 a/m. in front of house of informant at Nimgaon, Tal. Malshiras, Dist. Solapur, have member of an unlawful assembly, in prosecution of the common object of such assembly, and that you all thereby committed an offence punishable under Section 143 r/w Sec. 149 of the Indian Penal Code and within my cognizance.
2. **Secondly** : - That you accused, on aforesaid date, time and place, in furtherance of your common object, having member of an unlawful assembly, used force or violence by unlawful assembly, committed the offence that you all thereby

committed an offence punishable under Section 147 r/w 149 of the Indian Penal Code and within my cognizance.

3. **Thirdly** :- That you accused, on aforesaid date, time and place, in furtherance of your common object, were a member of an unlawful assembly committed an offence of rioting with stick, which used as a weapon of offence and is likely to cause death and thereby committed an offence punishable under Section 148 r/w Sec. 149 of the Indian Penal Code and within my cognizance.

4. **Fourthly** :- That you accused, on aforesaid date, time and place, in furtherance of your common object, were a member of an unlawful assembly voluntarily caused grievous hurt to the informant, by means of stick and thereby committed an offence punishable under Section 325 r/w sec. 149 of Indian Penal Code and within my cognizance.

5. **Fifthly** :- That you accused, on aforesaid date, time and place, in furtherance of your common object, were a member of an unlawful assembly voluntarily caused hurt to the informant by means of sticks, which is used as weapon of an offence is likely to cause death and thereby committed an offence punishable under Section 324 r/w sec. 149 of Indian Penal Code and within my cognizance.

6. **Sixthly** :- That you accused, on aforesaid date, time and place, in furtherance of your common object, were a member of an unlawful assembly, voluntarily caused hurt to informant and thereby committed an offence punishable under Section 323 r/w sec. 149 of the Indian Penal Code and within my cognizance.

7. **Seventhly** :- That you accused, on aforesaid date, time and place, in furtherance of your common object, were a member of an unlawful assembly, intentionally insulted by abusing the informant and thereby gave them provocation, intending that such provocation will cause them to break the public peace and thereby committed an offence punishable under Section 504 r/w sec. 149 of the Indian Penal Code and within my cognizance.

8. **Lastly** :- That you accused, on aforesaid date, time and place, were a member of unlawful assembly committed criminal intimidation by threatening the aforesaid informant to cause to grievous hurt, and thereby committed an offence punishable under Section 506 r/w sec. 149 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by me on aforesaid charge.
