I, M. N. Patil, Judicial Magistrate, F. C., (Court No. 4) Malshiras is hereby charge you,

1. Paigambar Ramjan Attar
Age 67 yrs., Occu. Labour,
2. Rubab Paigambar Attar
Age 37 yrs., Occu. Labour,

Both R/o Sumitra Colony, Velapur, Tal- Malshiras, Dist-Solapur

as follows,

1. **Firstly** :- That you accused, on 07.10.2023 at 1.30 pm, at Velapur, Tal. Malshiras, Dist. Solapur, in furtherance of your common intention, voluntarily caused hurt to the informant and witnesses by means of Iron pipe used as a weapon of offence, is likely to cause death, and that you thereby committed an offence punishable Under Section 324 r/w Sec. 34 of Indian Penal Code and within my cognizance
2. **Secondly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, voluntarily caused hurt to the informant and witnesses with fist and kick blows and that you have thereby committed an offence punishable Under Section 323 r/w Sec. 34 of Indian Penal Code and within my cognizance
3. **Thirdly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, intentionally insulted and abused the informant and thereby gave them provocation intending that such provocation will cause them to break the public peace and that you thereby committed an offence punishable Under Section 504 r/w Sec. 34 of Indian Penal Code and within my cognizance
4. **Lastly** :- That you accused, on aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening the

informant with injury on him person and thereby committed an offence punishable
Under Section 506 r/w Sec. 34 of Indian Penal Code and within my cognizance

And I hereby direct that you be tried by me on aforesaid charge.
