**ORDER BELOW EXH.01.**  
(Passed on this 18<sup>th</sup> day of March 2026)

The applicant Gangadhar Bhimsha Ireshetty, R/o. Jeur, Tal. Akkalkot is holding a bank account at Bank of India, branch Jeur bearing account No.073510400006055. He alleges an online fraud committed with him on 18/09/2025 whereby he lost Rs.35,400/- from his above mentioned bank account. He had lodged a complaint at the Cyber Cell Portal, Solapur Rural and it bears acknowledgment No.31909250172592 and an amount of Rs.25,000/- were freezed and Punjab National Bank has put it on hold. The concerned Cyber Cell officer directed the applicant to produce an order from the Court for defreezing the amount held at the bank account. He is ready to abide by with the conditions imposed by the Court. He relied upon verified copy of his Adhar Card, account statement having seal of the bank and duly signed by the bank official, copy of complaint made to Cyber Cell Portal Solapur Rural. He prayed for allowing the application.

**02.** The Police Inspector, Akkalkot South Police Station has filed say to the application and stated that, the amount of Rs.25,000/- is kept on hold by the Punjab National Bank and he had no objection to return the amount so freezed to the applicant by imposing conditions.

**03.** Ld. APP prayed for rejecting the application.


**04.** I have perused the application, say thereon, documents filed along with it and heard APP and advocate for the applicant. The applicant appears to be the victim of the online fraud and the statement of account

filed on record also reflects the said entry regarding debit amount of Rs.35,400/- on 18/09/2025. Thereafter applicant filed complaint with Cyber Cell Solapur Rural reporting the fraud vide acknowledgment No.31909250172592. In view of this, it appears that, the applicant is the victim and hence, his application is allowed with certain conditions. The applicant shall be entitled to the direction from this court regarding the release of his amount. A letter shall thereafter be issued to the concerned branch of Cyber Cell, Solapur Rural for transferring the amount of Rs.25,000/- to be deposited in the above mentioned account of the applicant at Bank of India branch Jeur, Tal. Akkalkot through online bank transfer only. The applicant shall furnish one surety of Rs.25,000/- and shall not close, or keep his bank account in inoperative state without intimation to this Court. He shall execute an indemnity bond of Rs.25,000/- before the Court and he provide his permanent address proof and active contact number as well as that of surety. The non-applicant, shall file the copy of this order at the time of filing of chargesheet, if the accused is known or arrested. The case papers be filed.
