**ORDER BELOW EXH. NO. 1**

This is an application for issuance of Heirship Certificate as per Section VIII of the Bombay Regulation Act, 1827.

2. Perused the application. Heard Ld. advocate for applicant.

3. It is the contention of applicant that, she is daughter of deceased Nagnath Kashinath Vaste and deceased Suman Nagnath Vaste. Her mother Suman died on 31/03/2025 at village Bhosare, Tal. Madha, Dist. Solapur and her father died on 28/04/2012 at Solapur. The applicant's brother Navnath Nagnath Vaste also died on 04/05/2018 at village Bhosare, Tal. Madha, Dist. Solapur. The applicant's sister Vanita Vishnu Chikale died on 07/11/2014. The parents of applicant were not executed any Will deed during their lifetime. The applicant's father Nagnath was serving as Teacher at Zila Parishad, Solapur. Being a daughter, the applicant has only legal heir of deceased Nagnath and deceased Suman. The applicant in need of Heirship Certificate to mutate her name in Pension record of deceased Nagnath. Hence, the present application.

4. No one appeared in the present matter. Citation and Public Notice was issued as per order of this Court. The applicant has produced on record news paper 'Sanchar' dated 15/08/2025 at Exh.8 and Citation at Exh.7. The applicant has filed her evidence affidavit at Exh.13 and affidavit of A.W.2 -Vishnu Shankar Chikhale at Exh.14, A.W.3- Vinayak Vishnu Chikhale at Exh.15, A.W.4- Prajakta Swapnil Bhajibhakare at Exh.16, A.W.5- Pravin Vishnu Chikhale at Exh.17 and A.W.6- Abhijit Navnath Vaste at Exh.18. The applicant has closed her evidence vide Pursis at Exh.19. The applicant has file Death Certificates of Nagnath Kashinath Vaste, Suman Nagnath Vaste, Navnath Nagnath Vaste, Vanita Vishnu

Chikhale and Aadhar Card of applicant vide list at Exh.4. The Block Development Office, Panchayat Samite through their Sr. Assistant has filed the service book documents of deceased Nagnath Kashinath Vaste vide application at Exh.23.

5. After publishing public notice in the news paper, nobody appeared and taken any objection during prescribed period for issuance of Heirship Certificate in the name of applicant. After going through record, it appears that except the applicant no other legal heirs are there for claiming Heirship Certificate of deceased. Hence, there is no hurdle to issue Heirship Certificate in the name of applicant.

6. Considering the aforesaid aspects and the relation of applicant with deceased given in application, I am of view that, applicant is the only legal heir of deceased Nagnath Kashinath Vaste. Hence, I pass following order.

**ORDER**

1.	The application is allowed.
2.	It is hereby formally recognized that the applicant is the legal heir of deceased Nagnath Kashinath Vaste died on dated 28/04/2012 at Chhatrapati Shivaji Maharaj Hospital, Solapur.
3.	Issue formal legal Heirship Certificate in favour of applicant to mutate her name in Pension record of deceased Nagnath Kashinath Vaste upon requisite Court Fee.
