**ORDER BELOW EXH. 01**

This is the application for issuance of Succession Certificate under Section 372 of Indian Succession Act 1925.

2. Perused the application. Heard Ld. advocate for applicants.
3. It is the contention of applicants that, applicants grand-mother Fulabai Trimbak Satpute is died on 06/09/2019. The applicant No. 1 is daughter of applicant No.2. The daughter of Fulabai, Usha Angad Palwe is also died on 01/12/2018. The applicant No.1 is only one daughter of deceased Usha. The applicants are take care of deceased Fulabai and incurred her death funeral expenses. Hence, the applicants are only legal heir of deceased Fulabai. There is amount of Rs.37,994/- in savings bank account bearing No.11520200348 at State Bank of India, Branch Madha in the name of deceased Fulabai. On 15/08/2023, the applicants approached to concerned bank for claiming said amount. The concerned official demanded Succession Certificate. Hence, present application.
4. Citation and Public Notice was issued as per order of this Court. The applicants produced on record citation at Exh.6 and news paper 'Dainik Tarun Bharat Sanwad' dated 12/11/2023 at Exh.7. The applicant No.1 filed her evidence affidavit at Exh.11. The applicants have filed the Death Certificates of Fulabai Trimbak Satpute and Usha Angad Palwe, verified copy of bank passbook of State Bank of India, Branch-Madha and bank statement of deceased Fulabai for the period of 01/01/2019 to 03/07/2024 in support of his contention.
5. After publishing public notice in the news paper, nobody appeared and taken any objection during prescribed period for issuance of Succession Certificate in the name of applicant. After going through record it

appears that except the applicant no other legal heirs are there for claiming Succession Certificate of deceased. Hence, there is no hurdle to issue Succession Certificate in the name of applicant.

6. Considering the aforesaid aspects and the relations of applicant with deceased given in application, I am of view that, applicant is the only legal heir of deceased Fulabai Trimbak Satpute. Hence, I pass following order.

**ORDER**

1.	The application is allowed.
2.	Issued Succession Certificate in the name of applicants as they are legal heir of deceased Fulabai Trimbak Satpute (फुलाबाई त्रिंबक सातपुते) in respect of the amount of Rs.37,994/- (Thirty Seven Thousand Nine Hundred Ninety Four Only) remaining in the State Bank of India, Branch Madha in the saving account No.11520200348 of deceased Fulabai Trimbak Satpute.
3.	The applicants to pay necessary Court Fees as per rule.
