There is urgency to restrain the defendants from constructing further in the suit property. I have gone through the record it reflects that present suit filed for possession of encroached portion and permanent injunction. The plaintiff prayed for temporary injunction order against defendants. In view of said prayer, I have minutely perused pleadings and documents. However, in my view, it is necessary to hear defendants before passing any ad-interim order. No exceptional case is made out for grant of ex-parte ad-interim order. Therefore, issue show cause notice to defendants as to why temporary injunction order should not be passed against them. R/o- 25.08.2025.
