ORDER

This is an application filed by applicant/accused for allowing him to travel abroad to U.K. for the period commencing from 11/06/2023

for 6(six) weeks.

2 Heard advocate for applicant/accused and APP for the State. Perused the ground in the application and reply filed by the State and considered the documents filed on record.

3 Advocate for applicant submits that the applicant is facing trial for the offences punishable under Sections 353, 332, 504 of Indian Penal Code. The case is pending for trial and it is fixed for recording of evidence of prosecution. The applicant want to go abroad on or about 11/06/2023 to U.K. for business purpose as a Technical Support Engineer and shall return to Mumbai after 6 (six)weeks. The Applicant undertakes that he will be attending the date listed after six weeks. The applicant has arranged for Visa and issued him valid Passport. He is ready to abide all the terms and conditions. Hence, prayed to allow the application.

4 The Ld. APP for the State objected the application by filing reply that applicant is going to U.K. and no address of U.K. has been mentioned in the application. There is chances of abscond. Hence, application may be rejected.

5 On perusal of the documents filed on record, it appears that there is itinerary giving details of places. The Identity Card of the applicant shows that he is permanent residence of Mumbai at the address mentioned in the application. The Passport bearing No.X8338145 shows that it is valid. The applicant has stated that he is going abroad for business purpose on or about 11/06/2023 as a Technical Support

Engineer and return after 6(six) weeks. He undertakes that he will be attending the Court on next date and in his absence, his advocate will be present. Having regards to the nature of offence and the ground mentioned in the application, the application deserves to be allowed. Hence, I pass following order -

ORDER

- 1 Application Exhibit-15 stands allowed.
- 2 The applicant **Shahrukh Sohrab Shaikh** is permitted to travel abroad at U.K. for the period commencing from 11/06/2023 for 6(six) weeks.
- 3 The applicant shall intimate his contact details and place of residence in abroad to the Kasturba Marg Police Station.
- 4 Application Exhibit-15 stands disposed of accordingly.
