ORDER

1. This order of mine shall dispose of above mentioned bail application moved by petitioner under Section 439 Cr.P.C.

2. As per allegations contained in the FIR, on 17.08.2023, at about 10.20 P.M in the area of Mohalla Guru Nanakpura, Nakodar, petitioner was found in possession of 190 intoxicating tablets without

label. Petitioner was arrested.

3. Upon notice, learned Additional P.P put in appearance and contested the bail application. Police record was produced.

4. I have heard rival contentions of learned counsel for petitioner as well as of learned Additional Public Prosecutor for State and perused the record.

5. Report of FSL has been received. As per report, the tablets recovered from the petitioner were having Tramadol Hydrochloride salt and each tablet was of 340 mg. The quantity of above salt as contained in tablets allegedly recovered from the petitioner, does not fall in the category of commercial quantity. Petitioner is in custody since 17.08.2023. Conclusion of investigation and presentation of challan will take sufficient long time. No purpose would be served by keeping the petitioner behind bars for indefinite period, as such, present application is hereby allowed and petitioner is admitted to regular bail on his furnishing bail bonds in the sum of ₹50,000/- with one surety in the like amount, subject to the following conditions:-

- i. That he shall not hinder the ongoing investigation;
- ii. That he shall not leave the country without prior permission of the Court;
- iii. That he shall not make any threat, promise or inducement to any person conversant with the facts of the case to dissuade him/her from disclosing the truth to the Court or police;

Bonds not furnished. Police record be returned. Copy of this order be

attached with remand papers. Record of bail application be consigned to the record room.
