



**Order Below Exh. 29 in R.D. No. 19/2015
(Maharashtra State Electricity Mandal, Satara Vidhag Vs. Dilip
Laxman Mule and Ors.)**

1. This application filed by the decree holder for attachment of the salary of the JD No. 2 Rajendra Narayan Salunkhe. It is contended that, total outstanding 1,38,000/-. Judgment debtors have failed to repay the amount. Therefore, the decree holder has brought on record salary slip of judgment debtor No. 2 which shows that, he is getting Rs.25,305/- per month after all deductions. JD failed to repay the amount. Therefore, decree holder prayed to attach salary of judgment debtor No. 2 for Rs. 7,000/- per month.
2. Record shows that, inspite of service notice judgment debtor failed to file say.
3. Heard Shri. G. V. Gore learned counsel for the decree holder. Other side is absent till 3:30 p.m. inspite of repeatedly calls.
4. Perused the record. Record shows that, judgment debtors are jointly severally liable for payment of Rs. 1,12,717/- along with 17% per annum interest on said amount from 31/07/2012. Salary slip brought on record by shows that, JD No.

2 Rajendra Narayan Salunkhe received net salary of Rs. 90,500/- per month and get Rs. 25,305/- per month after all deduction from Maharashtra State Power Generation Company Limited. This Darkhast is filed on in the year 2015 and since then as per the contention of the DH, JD failed to pay amount. There is nothing on record to show that, JD have paid amount. Hence, 1/3rd part of the salary of the judgment debtor No. 2 is required to be attached for the recovery of decretal amount. In the result I pass the following order.

ORDER

1. The application (Exh.29) is allowed.
2. The salary of the JD No. 2 Rajendra Narayan Salunkhe working at Maharashtra State Power Generation Company Limited is hereby attached till recovery of entire decretal amount along with interest.
3. Executive Engineer- Maharashtra State Power Generation Company Limited, Bhatghar Jal Viduyat Kendra, Wathar Vasahat, Tal-Khandala, Dist. Satara is hereby directed to deduct an amount of Rs. 7,000/- (Rupees Seven Thousand Only) per month from the salary JD No. 2 Rajendra Narayan Salunkhe from the salary of November 2025 paid in December 2025 till recovery of entire decretal amount along with interest.
4. Issue letter to Executive Engineer - Maharashtra State Power Generation Company Limited, Bhatghar Jal Viduyat Kendra, Wathar Vasahat, Tal-Khandala, Dist. Satara accordingly.
