Examination-in-chief by A.P.P. Smt. J.R. Ingale

My educational qualification is M.B.B.S.. I was working at PHC Bhuinj Tal. Wai Dist. Satara from September 2021 till today. I have experience of 6 years in medical profession. On 19.03.2022 I was working at PHC Bhuinj Tal. Wai, Dist. Satara as Medical Officer. On 19.03.2022 at 11:15 a.m. patients namely Anil Dagadu Salekar and Aasha Anil Salekar came to hospital without police yadi. I examined both patients and treated them. After examination of Anil Dagadu Salekar I found multiple abrasion, bite marks and blunt injury to different areas on body.

First injury is bite mark on right shoulder, redness and swelling noted, nature of injury is simple, kind of weapon is blunt and age of injury within 24 hours. Injury No. 2 bite mark on abdomen, redness present, nature of injury is simple, kind of weapon is blunt and age of injury within 24 hours. Injury No. 3 bite mark on right hand, redness present, nature of injury is simple, kind of weapon is blunt and age of injury within 24 hours. Injury No. 4 blunt injury on right shoulder, pain present, nature of injury is simple, kind of weapon is blunt and age of injury within 24 hours. Mole on upper chest noted for identification mark. MLC No. 115/2022 OPD No. 755/2022 is of Anil Dagadu Salekar. Today I brought medical register with me. Now

medical certificate dated 19.03.2022 of Anil Dagadu Salekar shown to me. It bears my signature and seal of hospital. The said certificate is issued as per MLC register. Contents of the certificate are true and correct. **Medical certificate of Anil Dagadu Salekar is marked at Exh. 43.**

Then, I examined patient namely Aasha Anil Salekar. After examination of Aasha I found that there was no injury but headache was present. Mole below left eye on cheek noted for identification mark. Headache can cause because of blunt injury. Injury is question mark because patient was complaining about the headache since 24 hours. MLC No. 116/2022 OPD No. 756/2022 is of Aasha Anil Salekar. Today I brought medical register with me. Now medical certificate dated 19.03.2022 of Aasha Anil Salekar shown to me. It bears my signature and seal of hospital. The said certificate is issued as per MLC register. Contents of the certificate are true and correct. **Medical certificate of Aasha Anil Salekar is marked at Exh. 44.**

Police requested me for opinion on 23.03.2022. On their request I issued my opinion in C.R. No. 75/2022. Injuries caused to the Anil Salekar can be caused by human bite. Now my opinion certificate shown to me. It bears my signature and seal of hospital. Contents of the opinion certificate are true and correct. **Opinion Certificate is marked at Exh. 45.**

Police again requested me for opinion on 17.05.2022 about the injuries of Anil Dagadu Salekar. I referred Anil Dagadu Salekar for expert opinion on the same date for whether injury of medical hernia operated or not. Now my opinion certificate shown to me. It bears my signature and seal of hospital. Contents of the opinion certificate are true and correct. **Opinion Certificate is marked at Exh. 46.**

Examination in chief over.

Cross-examination on behalf of accused by Advocate Smt. A.K. Shete

It is true to say that, I did not take identity proof of the patients when I examined them. It is not true to say that, patients not narrated the history of injuries. It is not true to say that, injuries caused to the patients were not fresh injuries. It is not true to say that, injuries caused to the patients can possible if patient fall on surface or bite of animals or by way of stone. It is not true to say that, I detailed not examined the injuries of patients. It is true to say that, medical certificates at Exh. 43 and 44 not bear the signatures of patients. I cannot state whether patients came to the hospital after 19.03.2022. It is not true to say that, I have not issued any certificate after 19.03.2022. It is true to say that, eyes will become red if contact with the force of air. It is not true to say that, I deposed false. It is not true to say that, I issued certificate at Exh. 43 and 44 without examining the patients. It is not true to say that, I deposed falsely.
