**ORDER BELOW EXH. 1**

This is an application for grant of Heirship Certificate under Rule 3 of The Bombay Regulation, VIII of 1827.

2) The applicants have contended that, father of the applicants namely Sampat Ganpat Kumbhar died on 16/11/2022. The applicant's father Sampat and mother Vandana got divorced on 8.05.2001. Since then, the applicants have been living with their father. Their father has been taking care of them and educating them. Applicants are only legal heirs of deceased Sampat Ganpat Kumbhar. They require Heirship Certificate for Official purposes. Thus, they prayed for issuance of Heirship Certificate.

3) The citation and proclamation in daily local newspaper namely "*Tarun Bharat*" was published on 11/02/2026, inviting all persons who dispute rights of the applicants to appear in the Court within one month from the date of proclamation and enter their objections. But neither any person appeared in the proceeding nor filed any objection to the rights of the applicants. Therefore, the application was proceeded further with evidence lead by the applicants.

4) Applicant No.1 has filed her affidavit in-lieu-of examination-in-chief (Exh.10) and reiterated the contents of main application. The applicants have also examined witness namely Dnyandev Ganpat Kumbhar (Exh.11). Applicants have relied upon following documents.

5) Perused the application and record. Heard Ld. Advocate for applicants. Admittedly, no one has objected to the rights of applicants within the prescribed period. Applicants have brought on record sufficient oral as well as documentary evidence in support of their contentions. Testimony of applicants have remained unchallenged. Therefore, same is required to be accepted. Thus, applicants are entitled for the Heirship Certificate. Hence, following order is passed.

### ORDER

- i) The application is allowed as per follows.
- ii) Issue Heirship Certificate in the names of applicants, by formally recognizing them as heirs of deceased **Sampat Ganpat Kumbhar** in prescribed form, after receiving the requisite Court Fees, as per rules.
- iii) Note as per Para 312 Chapter XIV of The Civil Manual should be appended to the Certificate.
