**ORDER BELOW APPLICATION FILED BY ACCUSED/APPLICANT FOR
PERMISSION TO GO ABROAD:**

1. Perused the application and say of concern police station. Read the say of Ld. APP. Read the documents filed with the application. Heard both sides. Applicant has completed his BBA Degree in the year 2019. He intends to go Spain for further studies i.e. Masters in Finance. He has taken admission/enrollment in Master in Finance Course in IE University Spain. The said course is for two years, one year studies and another one year for internship. Therefore he has made this application for travelling abroad for the period of two years i.e. from August 2021 to September 2023. Amboli Police Station has registered the case against him bearing C.R. No. 11/2018 for the offences punishable under sections 279, 338, 337 of IPC. He is ready to abide by terms and conditions in respect of permission to go abroad. Ld. APP has no objection for grant of application on certain conditions. Concern police station strongly objected on the ground of possibility of accused to abscond.

2. Offences punishable under sections 279, 338, 337 of IPC are alleged against accused. Ld. Advocate of accused is ready to conduct the case in absence of accused. Case will take its own time for its disposal. Accused is ready to abide by any conditions imposed by court. Therefore, I am of view that no prejudice will cause to the prosecution if the prayer of the applicant is granted with certain conditions. In this view of matter, application deserves to be allowed. Hence, I proceed to pass the following order:

ORDER

- 1 The application is allowed as observed above.
- 2 The applicant/accused is permitted to go abroad in country Spain for the period of two years from the Month of August 2021 to September 2023 subject to condition that he shall execute P.R. Bond of Rs.15,000/- and deposit cash of Rs. 10,000/- as a security.
- 3 The applicant/accused shall furnish his undertaking that, he will remain present before court, as and when required.
- 4 The applicant/accused shall furnish all the details of his address in Spain with Investigation Officer.
- 5 The applicant/accused shall submit verified copy of his Passport and other relevant documents with the Investigation Officer.
- 6 On his returning the applicant/accused shall inform the Investigation Officer, accordingly.
- 6 Applicant/accused shall obey all the Government's guidelines/orders in respect of Covid-19 of the Government of India and Government of Spain.
