1] Instant application (**Exh. 2**) has been filed by learned Counsel of appellant inter-alia contending that present Regular Civil Appeal No. 5/2025 is pending before this Court. Regular Civil Appeal No. 419/2023 to R.C.A. No.423/2023 are pending before the Court of District Judge-2, Wai (Shri.D.B.Mane). All these appeals have been arisen out of one and same decree. It is contended that all these matters including present R.C.A.No.5/2025 need to be decided by one and same Court. Lastly, it is requested to transfer present R.C.A.No. 5/2025 to the Court of District Judge-2, Wai.

2] It appears that, R.C.A. No. 5/2025 and R.C.A. No. 419/2023 to R.C.A. No.423/2023 are found to be arisen out of one and same decree of the learned trial Court passed in Special Civil Suit No. 28/2003 dated 10.05.2006. R.C.A. No. 419/2023 to R.C.A. No.423/2023 are older than present R.C.A. No.5/2025. As per administrative order passed by Hon'ble Principal District and Sessions Judge, Satara dated 30/05/2025, various cases have been transferred to District Judge -2 and Addl. Sessions Judge, Wai. In such order, following note is written.

'If cross complaints / matters are transferred to various courts by this order, then these matters be transferred to

any one court where old matter is pending’.

3] Having considered such note, R.C.A. No.5/2025 (i.e. present appeal) needs to be withdrawn from the file of this Court and it needs to be transferred to the Court of District Judge -2 Wai, for deciding the same together along with R.C.A. No. 419/2023 to R.C.A. No.423/2023 (which are old and pending before the Court of District Judge-2, Wai). In the result, following order is passed :

ORDER

1. Application (**Exh. 2**) is allowed.
2. R.C.A. No.5/2025 pending on the file of this Court i.e. District Judge-1, Wai shall be transferred to the Court of District Judge -2 Wai, (Shri.D.B.Mane), where other corresponding R.C.A. No. 419/2023 to R.C.A. No.423/2023 are pending.
3. Such order be sent to the Hon’ble District Court, Satara for the necessary information.
4. Copy of order be sent to the Court of District Judge- 2, Wai.
5. It be updated on C.I.S.
