ORDER BELOW EXHIBIT 5

(Ramesh Korade & ors. Vs. State of Maharashtra)

1. The applicants/accused Ramesh Mahadev Korade and Rakesh Sudama Ojha have filed this application for ad-interim pre-arrest bail, under Section 482 of the Bharatiya Nagarik Suraksha Sanhita 2023 in C.R. No.29/2026, registered at Phaltan Gramin Police Station, for offence punishable under Sections 351(3), 351(2), 338, 337, 336(3), 336(2), 335, 336(1), 318(4), 319(2), 318(3), 3(5) of The Bharatiya Nyaya Sanhita, 2023.

2. Heard applicant's Ld. counsel. Perused relevant record. It is argued by applicant's Ld. counsel that, applicant/accused are falsely implicated. Both were not on the relevant post in the Bank when the loan was taken. The complaint is lodged only to harm the social reputation of applicant nos.1 and 2. As the case is based on Sec.175(3) of B.N.S.S. 2023, custodial interrogation is not necessary. The entire dispute centers around official bank ledgers and correspondence, which is already made available for police investigation. Hence, ad-interim protection be granted.

3. Thus, from the overall allegations it reveals that, although the point centers around the documentary evidence, it is necessary to hear the prosecution on the point. Hence, the order -

- 2] Issue show cause notice to the opponent returnable on 26.05.2026.
