Order below Exh.1 in M.A.C.P No.404/2025

Perused mediation report at Exh.33 and compromise pursis at Exh.31.

2. The claimant Nos.1 and 3 alongwith their advocate are present before the Court. The claimants are identified by their learned Advocate. In view of mediation report, Exh.33 and compromise pursis at Exh.31 claimants have fully and finally settled their dispute with opponent No.2 for sum of **Rs.11,93,000/- (Rupees Eleven Lakh Ninety-Three Thousand Only)**. Consequently, opponent No.1 – owner is exonerated from liability. Hence, the order :-

ORDER

1.	Petition stands disposed of in view of compromise through mediation.
2.	Opponent No.2- Insurance Company do deposit settlement amount of Rs.11,93,000/- (Rupees Eleven Lakh Ninety-Three Thousand Only) within period of one month from the date of award , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
3.	If Opponent No.2 fails to comply, settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.
4.	Out of compensation amount given to claimants, Rs.3,96,500/- (Rupees Three Lakh Ninety-Six Thousand Five Hundred Only) be given to claimant No.1, Rs.2,00,000/-

	(Rupees Two Lakh Only) be given to claimant No.2 and Rs.5,96,500/- (Rupees Five Lakh Ninety-Six Thousand Five Hundred Only) be given to the claimant No.3.
5.	Compensation amount given to claimant No.2 be invested in fixed deposit in her name, in any Nationalized Bank, till she attains majority.
6.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimants after its maturity without asking further order of this Tribunal for its realization.
7.	Remaining compensation amount be transferred by RTGS or NEFT in the joint account No.0495104000298148 of claimant Nos.1 and 3 maintained at IDBI Bank, Branch – Jambhali Naka, having IFSC Code – IBKL0000495. Aadhar card number of claimant No.1 is 770903132185 and PAN card number is AEXPI4725B and Aadhar card number of claimant No.3 is 386416414559 and PAN card number is ACOPI3519E, as per award.
8.	Court fees be refunded to the claimants as per rule.
9.	Award be drawn up accordingly.
