


The dispute between the parties having been referred for determination to the Lok Adalat and the parties having compromised/settled the case/matter, the following award is passed in terms of the settlement :



3.	Opponent- Insurance Company shall deposit settlement amount of Rs.11,33,000/- (Rupees Eleven Lakh Thirty Three Thousand Only) including amount of N.F.L., within period of one month from the date of award , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
4.	If it fails to comply as per Clause 2 above, settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.
5.	Out of compensation amount given to claimants, Rs.1,33,000/- (Rupees One Lakh Thirty Three Thousand Only) be invested in fixed deposit for 3 years, in the name of applicant No.1 in any nationalized bank, as per her choice.
6.	Out of compensation amount given to claimants, Rs.50,000/- (Rupees Fifty Thousand Only) be invested in fixed deposit for 3 years, in the name of applicant No.2 in any nationalized bank, as per his choice.
7.	Out of compensation amount given to claimants, Rs.50,000/- (Rupees Fifty Thousand Only) be invested in fixed deposit for 3 years, in the name of applicant No.3 in any nationalized bank, as per his choice.
8.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimants after its maturity without asking further order of this Tribunal for its realization.

9.	Remaining compensation amount of Rs.4,00,000/- (Rupees Four Lakh only) be given to the claimant No.1 through RTGS or NEFT as per award.
10.	Remaining compensation amount of Rs.2,50,000/- (Rupees Two Lakh Fifty Thousand only) be given to the claimant No.2 through RTGS or NEFT as per award.
11.	Remaining compensation amount of Rs.2,50,000/- (Rupees Two Lakh Fifty Thousand only) be given to the claimant No.3 through RTGS or NEFT as per award.
12.	The claimants shall furnish their bank accounts details to this office by filing authentic copy of passbook/Bank documents.
13.	Court fee be refunded to the claimants, as per rule.
