Order below Exh.1 in M.A.C.P No.1172/2025

Perused mediation report at Exh.16 and compromise pursis at Exh.14.

2. The claimant alongwith their Advocate and Advocate for opponent No.2 are present before the court. The claimants are identified by their learned Advocate. In view of mediation report Exh.16 and compromise pursis at Exh.14 claimants have fully and finally settled their dispute with opponent No.2 for sum of **Rs.65,00,000/- (Rupees Sixty-Five Lakh Only)**. Consequently, opponent No.1 – owner is exonerated from liability. Hence, the order :-

ORDER

1.	Petition stands disposed of in view of compromise through mediation.
2.	Opponent No.2- Insurance Company do deposit settlement amount of Rs.65,00,000/- (Rupees Sixty-Five Lakh Only) within period of one month from the date of award , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
3.	If Opponent No.2 fails to comply, settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.
4.	Out of compensation amount, Rs.30,00,000/- (Rupees Thirty Lakh Only) be given to claimant No.1 and Rs.35,00,000/-

	(Rupees Thirty-Five Lakh Only) be given to claimant No.2.
4.	Out of compensation given to claimants, Rs.8,00,000/- (Rupees Eight Lakh Only) each be invested in fixed deposit for the period of 2 years, in their name, in any Nationalized Bank.
5.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimants after its maturity without asking further order of this Tribunal for its realization.
6.	Remaining compensation amount be transferred by RTGS or NEFT - in the joint account No.604016313 of claimant Nos.1 and 2 maintained at Indian Bank, Branch – Vashi Juhu Road, having IFSC Code – IDIB000V079. Aadhar card number of claimant No.1 is 630191611418 and PAN card number is ACOPY2072L and Aadhar card number of claimant No.2 is 636978083932 and PAN card number is AMPPY0937P, as per award.
7.	The opponent No.2 is directed to inform in writing to the claimants and the Tribunal after depositing the amount in M.A.C.T. Account by mentioning claim petition number, date of depositing amount, the amount, UTR number of NEFT or RTGS transaction and name of claimants.
8.	Court fees be refunded to the claimants as per rule.
9.	Award be drawn up accordingly.
