3.	Opponent- Insurance Company shall deposit settlement amount of Rs.29,50,000/- (Rupees Twenty Nine Lakhs Fifty Thousand only) including amount of N.E.L., within period of one month from the date of award , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
4.	If it fails to comply as per Clause 2 above, settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.
5.	Out of compensation amount, 25% amount each be given to claimants No.1 to 3, 5% amount be given to claimant No. 4 and 20% amount be given to claimant No.5.
6.	Compensation amount given to claimants No.2 and 3 be invested in fixed deposit, in their names in any nationalized bank of their native, as per the choice of claimant No.1 till they attain majority.
7.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimants after its maturity without asking further order of this Tribunal for its realization.
8.	Compensation amount be given to the claimants No. 1, 4 and 5 by RTGS or NEFT, as per award.
9.	The claimants shall furnish their bank accounts details to this office by filing authenticate copy of passbook/Bank documents.
10.	Court fee be refunded to the claimants, as per rule.
