
**AWARD**



3.	Opponent- Insurance Company shall deposit settlement amount of <b>Rs.16,50,000/- (Rupees Sixteen Lac and Fifty Thousand Only)</b> including amount of N.F.L., <b>within period of one month from the date of award</b> , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
4.	If it fails to comply as per Clause 2 above, <b>settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.</b>
5.	Out of compensation amount given to claimant, <b>Rs.5,00,000/- (Rupees Five Lakh Only)</b> be invested in fixed deposit in the name of applicant Nos. 2/mother, for the period of three years, in any nationalized bank, as per her choice <b>and Rs.5,00,000/- be given to applicant No.2/mother by RTGS/NEFT</b> as per award.
6.	Out of compensation amount given to claimant, <b>Rs.1,00,000/- (Rupees One Lac Only)</b> be invested in fixed deposit in the name of applicant Nos. 1/father, for the period of three years, in any nationalized bank, as per his choice <b>and Rs. 5,50,000/- (Rs. Five Lac &amp; Fifty Thousand only) be given to applicant Nos.1/father through RTGS/NEFT</b> as per award.
7.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimant after its maturity without asking further order of this Tribunal for its realization.
8.	The claimants shall furnish their bank accounts details to this office by filing authenticate copy of passbook/Bank documents.

9.	Court fee be refunded to the claimant, as per rule.
