3.	Opponent- Insurance Company shall deposit settlement amount of <b>Rs.16,35,000/- (Rupees Sixteen Lakhs Thirty Five Thousand Only)</b> including amount of N.F.L., <b>within period of one month from the date of award</b> , in bank account of the Motor Accident Claims Tribunal, Thane, by RTGS or NEFT, as per directions of the Hon'ble Apex Court in Writ Petition No. 534/2020.
4.	If it fails to comply as per Clause 2 above, <b>settlement amount shall carry interest @ 8% p.a. from the date of award till its actual realization.</b>
5.	Out of compensation amount, <b>Rs.8,17,500/- (Rupees Eight Lakhs and Seventeen Thousands and Five hundred Only)</b> each be given to claimant No.1 and 2.
6.	Out of compensation amount given to claimant No.1, <b>Rs. 4,08,750/- (Rupees Four Lakhs Eight Thousand Seven Hundred and fifty Only)</b> be invested in fixed deposit for 5 years, and out of compensation amount given to claimant No.2, <b>Rs.3,00,000/- (Rupees Three Lakhs Only)</b> be invested in fixed deposit for 3 years, in their names in any nationalized bank of their native, as per their choice.
7.	The branch manager of concerned bank is directed to pay the amount of fixed deposit with interest to concerned claimants after its maturity without asking further order of this Tribunal for its realization.
8.	Remaining compensation amount be given to the claimants by account payee cheque in their bank accounts, as per award.
9.	The claimants shall furnish their bank accounts details to this office by filing authenticate copy of passbook/Bank documents.
10.	Court fee be refunded to the claimants, as per rule.
