The present application is filed for second time for seeking bail under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023, in connection with Crime No.491/2026 registered with Police Station, Seloo for the offences punishable under Section 109(1) of the Bharatiya Nyaya Sanhita, 2023.

2] It is the case of the prosecution that on 04.07.2026 when the informant was preparing to sleep after dinner his cousin brother came to visit and informed that when he has thrown the wrapper of kharra on road, the applicant picked up quarrel with him twisted his fingers and beat him with wooden log. When the informant along-with the victim Karan went to accused and accused him as to why he has done this on truffle matter, the applicant picked up quarrel with him went to his house, bring a thermocol cutter and inflicted blows on victim's chest right arm, right thigh in order to kill him. Karan on the ground due to heavy bleeding. He was saved by the informant and other

person and referred to Seloo Hospital. Report was lodged in pursuance of which offence is registered against the applicant.

3] Investigation is taken up by PSI Umesh, he referred informant to the Kasturba Hospital where the dying declaration of victim was recorded wherein he disclosed the incident. Accused were arrested. Weapon used in crime is seized at the instance of the applicant. The thermocol cutter was recovered statement of witnesses came to be recorded. The applicant is before the Court for bail.

4] According to the applicant, he is totally innocent, there is no eye witness. Injured is already discharged from the hospital. Old aged parent wife and children are depend on him. He will be release on bail and if ne is not release on bail they may suffered.

5] The present application is opposed by the investigating officer by filing reply Exhibit-7. According to him, the offence is serious if the accused is released on bail the possibility can not be ruled out that he may again, commit same nature of affence and may influence the witnesses.

6] Heard ld. APP and ld. counsel for the accused. Perused the case diary. From the bare perusal of FIR and the dying declaration, it appears that applicant victim has specifically named the applicant. Initially the applicant on very trifle matter beat the victim by wooden lock and when the family members of victim appreciated him asked about the attack, the applicant went into his house and bring a sharped aged wooden cutter and inflicted blow on the vital part of the victim.

7] The medical certificate filed in the case diary shows that there is a lacerated wound of about 6.4 cm X 4.0 cm to the right side of chest lacerated wound of 4.3 X 2.0 cm to right arm and lacerated wound of 7.4 X 2.0 cm. below right knee. Act of the accused in bringing sharpened edged weapon and inflicting blow on the victim on vital part speaks volumes about his intention. Apart from the medical certificate there are eye witnesses who witnessed the incident.

8] It appears that the applicant is resident of the same locality where the victim and informant resides. Considering the manner in which crime is committed, possibility can not be ruled out that if the applicant is released on bail, he may again influence or pressurize the victim or the witnesses. Therefore, I am not inclined to grant him bail. Hence, the order :

:: ORDER ::

- (i) Application is rejected.
- (ii) Case diary be returned to the Investigating Officer.
- (iii) Inform the concerned Police Station accordingly.
