ORDER BELOW EXH.21

(Passed on 11th October, 2024)

- 1] Present application is filed by accused No.7 for temporary bail.
- 2] According to the applicant-accused, she is facing trial since last one year. Out of nine accused, six accused are already released on bail but she is still behind bar. Her mother Lalita Kodape is suffering from breast cancer and needs for medical assistance, therefore, one month bail for temporary period be granted to her.
- 3] Application is opposed by prosecution by filing say at Exh.24. Only objection is taken by prosecution that offence is serious. If the accused is released on bail, she may tamper the prosecution evidence. Applicant-accused is involved in commission of brutal murder of the deceased and therefore, application be rejected.
- 4] Heard learned APP and learned counsel for the accused. Applicant is not claiming bail on merit but temporary bail for one

month only to look-after her mother. Learned APP has also not taken serious objection and submitted that appropriate order may be passed.

5] I have gone through the record. Medical certificates filed by applicant show that her mother is suffering from ca ® breast. Thus, it is apparent that she needs medical assistance. The applicant is praying in her application that now she is behind bar and trial may take its own time. The charge-sheet is already filed. No prejudice would be caused to the prosecution if applicant is released on temporary bail for the period of one month after imposing some conditions. Hence, the following order.

ORDER

- 1] The application is hereby allowed.
- 2] Applicant / accused Punam Satish Irpache, be released on temporary bail for the period one month only on executing PR bond of Rs.50,000/- (Rupees Fifty Thousand only) with solvent surety in like amount
- 3] The applicant shall not tamper with the prosecution evidence in any manner whatsoever and shall not contact any of the prosecution witnesses.
- 4] The applicant to surrender herself before the court after one month of her released from the jail.
- 5] The applicant to provide her address proof of her residence during one month and also her registered mobile phone number.
- 6] The applicant to visit Police Station Pulgaon weekly to mark her presence.
- 7] Application is disposed off accordingly.
