Order below Supratnama Application Exh. 1
(Dt. 04/05/2026)

The present application has been filed for seeking the release of Bajaj Pulsar Motorcycle bearing Registration no.MH-32 H-5449 (Chassis no. DHVBLJ08634 and Engine no. DH9BLJ0 8038) seized by the Police Station, Wardha City in Crime no. 80/2026 for the offence punishable U/s. 303(2) of the B.N.S. The say of Investigation officer makes it clear that, the said vehicle has indeed, been seized by the police. However, the I.O. has not objected to release the above vehicle. Ld. A.P.P. has also not objected to release the above vehicle in favour of the applicant.

2. Adv. Smt. Phalke for the applicant has submitted that, the applicant has lodged F.I.R. when said vehicle was stolen by unknown accused. The applicant is the owner of the said vehicle and he is ready to abide all the terms and conditions imposed by the Court. She has further prayed for the release of the said vehicle.

3. Perused the documents filed by the applicant, i.e. verified copy of in lieu of registration certificate of the abovesaid vehicle, which is in his name. The applicant has also filed copy of F.I.R. and copy of his Aadhar card as an identity proof. From the above documents, *prima facie* it is proved that, the applicant is owner of the said vehicle. No fruitful purpose will be served by keeping the abovesaid vehicle idle. The applicant undertakes to abide conditions which will imposed in the event his application is allowed. He is legally entitled for the same as per documents filed. Therefore, this Court thinks it is proper to release the abovesaid vehicle on supratnama in favour of the applicant imposing certain conditions. Hence, following order -

ORDER

- 1) The application is allowed.
- 2) The applicant shall furnish to the investigating officer two self attested colored photographs of the vehicle for the purpose of the identification. The investigating officer shall facilitate the photographs.
- 3) The applicant shall produce the vehicle as and when directed by the Court.
- 4) The applicant shall not transfer, alienate and change the nature of the vehicle till the conclusion of trial.
- 5) The applicant shall execute a Supurtnama bond at concern police station binding himself abide by the above conditions No. 3 to 5 and in default to forfeit Rs. 50,000/- (Rs. Fifty Thousand only) to the Government.
- 6) After execution of the Supurtnama bond and furnishing colored photographs by the applicant, the investigating officer shall handover the custody of seized Bajaj Pulsar Motorcycle bearing Registration no. MH-32 H-5449 (Chassis no. DHV BLJ08634 and Engine no. DH9BLJ0 8038) to the applicant.
- 7) This proceeding be tagged with the case papers as and when final report is received in the same crime.
- 8) Issue copy of this order to the investigating officer for its compliance.
