COMPLAINT FOR OFFENCE U/S. 138 R/W SEC. 142 OF THE
NEGOTIABLE INSTRUMENTS ACT 1881.

The Complainant above named most respectfully submits as
under:-

1. That the complainant herein is a company registered and
incorporated as such under the provisions of the Indian Companies Act,
1956 and is having its registered office, corporate office and also branch
office at the respective addresses mentioned in the cause title of this
complaint case. The complainant Company is engaged inter alia in the
business of providing finance for Two Wheeler, Three Wheelers, Four
Wheelers, Personal Loan, Trade Loan and other financial products.

2. That, the present complaint is signed, verified and filed by the Complainant-company through its Executive and duly constituted and authorized Attorney – Shri. Shubham s/o Gajanan Charde by virtue of the Power of Attorney dated 01/11/2023 duly executed in his favour and authorization given to him by the Complainant Company. Accordingly, by virtue of the said duly notarized Power of Attorney and authorization, Shri. Shubham s/o Gajanan Charde is duly authorized, competent and empowered inter alia to sign, verify and file the present complaint case and to do all such various acts, deeds and things as may be necessary and incidental to the powers conferred upon him under the said Power of Attorney/ authorization.

3. The Complainant Company submits that, the accused approached to Complainant Company for Personal Loan and obtained Loan of **Rs. 60000/- (Rupees Sixty Thousand Only)** from the complainant as per the terms and condition of the Agreement No. **WRDHAPL2311290001** executed and signed on **29/11/2023** by the accused in favour of the Complainant Company. The loan was to be repaid by accused in 24 monthly installments of Rs.3634/- each commencing from 05-01-2024. However, as per agreement accused have to regularly repay the monthly installment amount before due date, but accused failed to maintain repayment schedule as aforesaid and committed several defaults. Therefore the accused become liable to repay the entire outstanding dues to the Complainant. On 08/12/2025 when the accused came to the complainant office and asked about as on balance arrears amount up to 08/12/2025 against her, then at that time amount of Rs. 29,006/- towards Regular installment amount remains due against the accused on the said day and for making repayment Rs. 29,006/- the accused has issued the cheque bearing No. 338782 ,dated 09/12/2025 for amount of Rs. 29,006/- drawn on “State Bank Of India, Branch Wardha”, in favour of Complainant in discharge of her as on date arrears liability under the

loan agreement. The accused further given assurance of encashment of the Cheque, and instructed the complainant to present the said cheque in the bank for realization of amount.

4. The Complainant Company presented the said cheque to its bankers namely AXIS Bank Ltd., Branch Wardha on 24/12/2025, for its realization and encashment. But the amount of money standing to the credit of the account of accused in her said bank at the time of the encashment of the said cheque was insufficient to honour the said cheque. As a result, the said cheque was dishonored and returned back with the reason remark "Funds Insufficient". Thereafter the said cheque returned back to the complainant company with reason/remarks "Funds Insufficient" with cheque Return memo dt. **24/12/2025** issued by Axis bank Branch Wardha as per return processing guidelines specified in National Grid Clearing House Guidelines.

5. The Complainant Company states that, the accused having knowledge that, the cheque issued by her would be dishonored, dishonestly issued the same to the complainant and thereby the Accused committed offence under section 138 of the Negotiable Instruments Act and she is liable to be punished for the offence under section 138 of the Negotiable Instruments Act.

6. That, the Complainant Company through Shri. Amol C. Kotambkar, Advocate, called upon the accused by Legal Notice dated 29/12/2025 by Registered post with acknowledgement due to make the payment of the aforesaid dishonored Cheque within 15 days from the date of receipt of said notice. It is submitted that, Complainant sent the notice on the addresses to accused i.e. on her residential address. By the said legal notice the accused was specifically cautioned that, if the payment as called upon was not made within 15 days, then the accused will be liable for committing an offence punishable under section 138 of

Negotiable Instrument Act 1881. The said Legal/Demand notice has been received by the accused on dated **30/12/2025**. After receiving the notice, accused has not paid the cheque amount and as such intentionally and knowingly committed offence punishable under section 138 of Negotiable Instrument Act, 1881.

7. That, the accused has committed offence under section 138 and section 142 of the Negotiable Instruments Act and the complainant has filed this complaint to seek punishment for the accused and compensation for himself under the provisions section 357 of Cr. P.C.

8. That, the cause of action for filing the present complaint case against the accused arose within the territorial jurisdiction of this Hon'ble Court the accused neglected and failed to pay off the amount of the aforesaid dishonored cheque under reference to the complainant Company. The Complainant has filed Court Fee Stamp of Rs. 600/- along with this complaint.

9. That, the present complaint case being filed by the Complainant Company before this Hon'ble Court today i.e. on 10 /02/2026 prior to on 12/02/2026 is well within the limitation prescribed by the law.

10. That, the Complainant Company is filing documents as per the list separately annexed herewith, in support of the present complaint case and craves leave of this Hon'ble Court to file more afterwards as and when deemed necessary. The Complainant will examine the following witnesses in support of its complaint.

1. Executive and G.P.A. Holder Shri. Shubham s/o Gajanan Charde.
2. Concerned officials of "State Bank Of India, Branch Wardha".
3. Concerned officials of Axis Bank Ltd., Branch Wardha.
4. Postal Authority.
5. Other Concerned Witnesses.

11. It is submitted that no other complaint had been filed in any other court except this court in respect of the above mentioned cheque transaction.

PRAYER :- It is, therefore, most humbly prayed that :

[A] The accused may kindly be summoned, tried and punished as per the law, for committing the offence under Sections - 138 read with Section -142 of the Negotiable Instruments Act, 1881, as amended by the Act, 2002.

[B] The accused may kindly be ordered to pay to the complainant Company by way of compensation, such amount, as may be deemed fit and appropriate by this Honorable Court in the facts and circumstances of the case, as per the relevant provisions of Section - 357 of the Code of Criminal Procedure.

[C] Costs be kindly made to follow the events.

[D] Any other relief, which deems fit and proper under the facts and circumstances of the case may also be kindly granted to the complainant.
