Order below Supratnama Application Exh. 1
(Dt. 21/04/2026)

The present application has been filed for seeking the release of Hero HF Delux Motorcycle bearing Registration no.MH-32 AL-8512 (Chassis no. MBLHAR202HGM07032 and Engine no. HA11ENHGK04082) seized by Police Station, Wardha City in Crime no.162/2026 for the offences punishable U/s. 122 of the Maharashtra Police Act. The say of Investigation Officer makes it clear that, the said vehicle has indeed, been seized by the police. However, the I.O. has objected to release the above vehicle. Ld. A.P.P. has also objected to release the above vehicle in favour of the applicant.

2. Ld. Adv. Dhole for the applicant has submitted that, the applicant is the owner of the said vehicle and he is ready to abide all the terms and conditions imposed by the Court. He has further prayed for the release of the said vehicle.

3. Perused the documents filed by the applicant, i.e. verified copy of registration certificate of the abovesaid vehicle, which is in his name. The applicant has also filed copy of his Aadhar card as an identity proof. From the above documents, *prima facie* it is proved that, the applicant is owner of the said vehicle. No fruitful purpose will be served by keeping the abovesaid vehicle idle. The applicant undertakes to abide conditions which will imposed in the event his application is allowed. He is legally entitled for the same as per documents filed. Therefore, this Court thinks it is proper to release the abovesaid vehicle on supratnama in favour of the applicant imposing certain conditions. Hence, following order -

| 2) | The applicant shall furnish to the investigating officer two self attested colored photographs of the vehicle for the purpose of the identification. The investigating officer shall facilitate the photographs. |
| 3) | The applicant shall produce the vehicle as and when directed by the Court. |
| 4) | The applicant shall not use the vehicle for any offence or any illegal activity by himself or by another. |
| 5) | The applicant shall not alienate the vehicle without prior permission of the Court. |
| 6) | The applicant shall execute a Supurtnama bond at concern police station binding himself abide by the above conditions Nos. 3 to 5 and in default to forfeit Rs. 50,000/- (Rs. Fifty Thousand only) to the Government. |
| 7) | After execution of the Supurtnama bond and furnishing colored photographs by the applicant, the investigating officer shall handover the custody of seized Hero HF Delux Motorcycle bearing Registration no. MH-32 AL-8512 (Chassis no. MBLH AR202HGM07032 and Engine no. HA11ENHGK0 4082) to the applicant. |
| 8) | This proceeding be tagged with the case papers as and when final report is received in the same crime. |
| 9) | Issue copy of this order to the investigating officer for its compliance. |
