Examination-in-Chief by Mr.S.M.Dunge Ld.A.P.P.for the State.

1] I am educated upto B.A.M.S. in the year 1984. I have been serving as medical officer since 1996. On 08-05-2022, I was attached to Civil Hospital, Wardha as C.M.O. On that day, the patient namely Pawan Subhashrao Gosewade was brought by N.P.C. Prakash B.No.1505 of P.S.Sewagram at 6.30 p.m. along with requisition letter. Now, requisition letter is shown to me. It is the same. It bears my signature as recipient. It is at **Exh.28**. The patient told me history of assault by someone. On physical examination of Pawan, he was found conscious. It was found that he had one abrasion wound on left side of forehead measuring 2.00 inch x ½ inch. Said injury was fresh. Accordingly, I issued injury certificate. The certificate shown to me is the same. Its contents are true and correct. It bears my signature and seal of the office. It is at **Exh.29**. I can identify the patient on the basis of identification mark i.e. black mole on left side of nose. The injury was simple in nature and it can be caused with the hard and blunt object irregular shape.

2] On 10.06.2022, Police brought the weapon for query report. Accordingly, I received requisition letter about query report. Now, the requisition shown to me. It bears my signature as recipient. It is at **Exh.25**. Accordingly, I had issued query report. The report now shown

to me is the same. It bears my signature. Its contents are true and correct. It is marked at **Exh.26**. The object was sealed when received by me. I had resealed it after examination and it bears my signature. I can identify that seized weapon. The stone now shown to me is the same. It is at **Article 'अ'**. The injury caused to the patient was possible with the stone (Article अ). Now, the resealed label shown to me. It bears my signature. It is at **Exh.30**.

Cross-examination by Ld. Advocate Shri.D.P. Borkar for the accused :-

3] It is not true to say that I have not mentioned about the weapon used for assault in the injury certificate at **Exh.25**. It is true to say that the injury may be caused due to fall on iron gate but it must be seen shape of that iron gate. It is not true to say that I am deposing falsely.
