Examination-in-Chief by Mr.S.M.Dunge Ld.A.P.P.for the State.

1] I am educated upto M.B.B.S. M.D. I have been serving as medical officer since 2017. On 10-09-2021, I was attached to Rural Hospital, Deoli. On that day, the patient namely Gajanan Motiramji Dhone was brought by N.P.C. Yogesh B.No.727 of P.S.Deoli at 9.31 a.m. along with requisition letter. Now, requisition letter is shown to me. It is the same. It bears my signature as recipient. It is at **Exh.63**. The patient told me history of assault by someone around 7.30 a.m. On physical examination of Gajanan, he was found conscious. It was found that he had two incise wounds on posterior aspect of right leg measuring 1.00 cm x 0.5 cm. and other one was 1.00 c.m. x 1.00 c.m. Those injuries were caused before two hours. Accordingly, I issued injury certificate. The certificate shown to me is the same. Its contents are true and correct. It bears my signature and seal of the office. It is at **Exh.64**. I can identify the patient on the basis of identification mark i.e. tatoo 'गजानन' on right arm. The injury was simple in nature and it can be caused with the sharp object.

2] On 17.09.2021, Police brought the weapon for query report. Accordingly, I received requisition letter about query report. Now, the requisition shown to me. It bears my signature as recipient. It is at **Exh.59**. Accordingly, I had issued query report. The report now shown

to me is the same. It bears my signature. Its contents are true and correct. It is marked at **Exh.65**. The object was sealed when received by me. I had resealed it after examination. I can identify that seized weapon. The sickle now shown to me is the same. It is at **Article 'अ'**. The injury caused to the patient was possible with the sickle (Article अ).

Cross-examination by Ld. Advocate Shri.U.P. Kashikar for the accused :-

3] I have gone through the requisition (Exh.59). It is true to say that it is not mention therein that the sickle was sealed. It is not true to say that I have never checked the article. It is not true to say that if it is possible that if someone falls on the hard, rough and sharp pointed object, he may receive the injuries stated in the chief-examination. It is not true to say that I have not examined Mr.Gajanan and have deposed on the say of police.
