Examination-in-Chief by Mr.S.M.Dunge Ld.A.P.P.for the State.

1] I am educated upto B.A.M.S. I have been serving as medical officer since 1992. On 09-05-2018, I was attached to Casualty Department Civil Hospital, Wardha. On that day, the patient namely Mithun Jivan Datta was brought by P.C.Raju B.No.738. Accordingly, I have received requisition letter. Requisition letter now shown to me is the same. It is at **Exh.33**. The patient told me history of assault by someone with knife. On physical examination of Mithun, he was found conscious. It was found that he had incise wound over left side elbow region measuring 2.00 cm x 0.5 cm. x 2.00 c.m. It was a deep injury with profuse bleeding. He complained of numbness of left hand finger. It was the fresh injury. It may have been caused by sharp object. Identification mark of the patient was black mole over left side of collar bone (clavicle). Accordingly, I have issued medical certificate. Medical certificate now shown to me is the same, it bears my signature. Its contents are true. It is at **Exh.34**. He was referred to M.G.M.I.S. Hospital.

2] On 25.06.2018, I had received a letter of query on the point of seized weapon. It is at **Exh.35**. The seized weapon was a sealed knife. It was unsealed by me. I have checked the weapon. It was black coloured knife having symbol of butter-fly in white colour bearing length 21.5

cm. and blade was 9 cm in length. The knife now shown to me is the same. It is at article 'A'. The injury mentioned in Medico Legal Certificate **Exh.34** can be caused by this knife. Accordingly, I had issued query report. The report now shown to me is the same. It bears my signature. Its contents are true and correct. It is at **Exh.36**. The knife was sealed when received by me. I had resealed it after examination. The sealed knife bears my signature. It is at **Exh.37**.

Cross-examination :

The accused and his advocate are absent when called till 12.50 p.m. Hence, order of no cross-examination is passed.
